1. General:

LBS Institute of Technology for Women Poojappura, Thiruvananthapuram is offering two Post Graduate Courses in Engineering:

1. Electronics and Communication Engineering with specialization in Signal Processing (SP)-24 seats

2. Computer Science and Engineering (CSE) - 24 Seats

The course shall extend over 24 months consisting of 4 semesters. Applications in the prescribed form are invited from eligible women candidates who meet the minimum eligibility criteria.

2. About the College:

LBS Institute of Technology for Women, Poojappura, Thiruvananthapuram, which started functioning in 2001, is the second Engineering College managed by LBS Centre for Science and Technology, Thiruvananthapuram. This is the only Engineering College for Women in the Government Sector in the state of Kerala. The institution is accredited by NBA for 4 UG Courses.

LBS Centre for Science & Technology, Thiruvananthapuram, and the premier institution of Computer Training / consultancy and Engineering consultancy was established by the Government of Kerala in 1976. The Centre is administered by a Governing Body and an Executive Committee. The Hon'ble Chief Minister is the Chairman of the Governing Body and the Hon'ble Minister for Higher Education is the Vice-Chairperson. The Principal Secretary for Higher Education is the Chairperson of the Executive Committee and the Director of Technical Education is the Vice-Chairperson. There are two Government cost-sharing Engineering Colleges under LBS Centre viz. LBS College of Engineering, Kasaragod and LBS Institute of Technology for Women, Thiruvananthapuram.

2.1 Location

The college is situated in the heart of Thiruvananthapuram city at Poojappura which is about 4km from Thiruvananthapuram Central Railway Station and KSRTC Bus Station. The nearest Airport, Thiruvananthapuram International/Domestic Airport is about 11/15km from the college.

2.2 Facilities

- a) The total building area on the college campus is 2,00,000sq.ft.
- b) Highly qualified, experienced and dedicated faculty
- c) Well-equipped laboratories and workshops.
- d) Career Guidance Placement unit [CGPU] and excellent campus placement.

- g) High-speed Internet facility for all students and staff.

- h) Wi-Fi Enabled campus.
- i) Well-supported college office.
- j) CCTV in all classrooms.
- k) Parent-Teacher Association.
- l) Transportation and Communication Facilities for students.
- m) National Service Scheme-Two units
- n) Physical Education to students.
- o) Nature club.
- p) Group Advisory System.
- q) Elected College Union and Department Technical Associations
- r) Alumni association.
- s) Other associations like IEEE, CSI, IGS etc.
- t) Smart classrooms
- u) Transportation facility covering the entire Trivandrum city
- v) Co-operative society provides all the stationery and textbooks
- w) All the Government scholarships available for meritorious students and internal scholarships instituted by the PTA Alumni Association are also available

2.3 Technical Education Quality Improvement Programme (TEQIP)

The Institute is selected for participation in the Technical Education Quality Improvement Programme (TEQIP-II), implemented by MHRD, the Government of India and funded by the World Bank. The academic and infrastructural facilities are enhanced and strengthened with assistance from TEQIP-II.

2.4 Career Guidance and Placement Unit (CGPU)

This unit is formed to bring the students and industrial fraternity on a common platform, thereby enhancing the scope for gainful employment of students. The unit is headed by a senior staff member with representation from both students and staff. The CGPU helps in arranging industrial training, group discussions, entrepreneurship training etc. More than 80% of outgoing students are getting placement in reputed National and Multi-National Companies.

3. Eligibility for Admission:

3.1 General Conditions:

- a. The candidates shall be female Indian Nationals.
- b. The candidates should have studied the Graduate course in an institution approved by the AICTE/Deemed Universities in India.
- c. Candidates should have a minimum of 60% aggregate marks in the Engineering Degree examination. For SC/ST candidates a pass in the Engineering Degree course is sufficient. For SEBC students a minimum of 55% aggregate marks in the Engineering Degree Exam is mandatory.

d. Candidates, who have passed AMIE/AMIETE Examinations and satisfy the following conditions are eligible for admission.

- 1) They must have a valid GATE score.
- 2) A minimum of 55% marks for section B in the AMIE/AMIETE examination.
- 3) Minimum three years of professional experience in the field of Specialization after acquiring the qualifying degree.

4. Selection of Candidates:

The selection procedures for different categories of M. Tech seats are as follows.

SL No.	Category	Selection Procedure
1	Merit Quota (75% seats of total approved intake of each discipline)	Seats filled by DTE
2	Sponsored Quota (25% seats of the total approved intake of each course out of which one seat in each course is reserved for eligible applicants from LBS Engineering Colleges/LBS)	Based on Qualifying Examination marks and experience in the ratio 8:2. For Sponsored candidates, a minimum of 2 years of Experience is required. 4 marks will be granted for each additional year of experience limited to a maximum of 20 marks. In case of a tie, an advantage will be given to the applicants with more experience. In the absence of sufficient applications in sponsored quota, the vacant seats will be converted to open merit seats and selection will be done accordingly.

Seats are reserved for SC/ST and other backward communities as per the reservation policies of Kerala Government/ University.

5. Course Structure:

Four-semester programme with a total duration of two academic years will include lectures, laboratory work, seminars and thesis work in the relevant area of the specialization. The course content will be as per the syllabus prescribed by KTU.

6. Distribution of Seats:

- a. 75% of seats of the approved intake of each M.Tech Programme will be filled up from open merit by observing the reservation policies of the Government /University.
- b. 25% of seats of the approved intake of each M. Tech Programme are reserved for eligible candidates from Educational / Research Institutions approved by AICTE/UGC/Govt/Universities or Industry out of which one seat is reserved for eligible candidates from Engineering Colleges under LBS Centre for Science and Technology.
- c. Unavailed seats if any under reservation /sponsored quota will be filled up from open merit.
